### Rating Rationale

Acuite has reaffirmed the long term rating of ‘**ACUITE C**’ (read as **ACUITE C**) on the Rs. 9.50 crore bank facilities of Wud Tools. The rating continues to be flagged as “Issuer Not Cooperating” and is based on the best available information.

### About the Company

Wud Tools (WT) is a partnership firm established in 1965. The firm is engaged in the manufacturing of cutting tools and blades like bias cutters, disc knives, Auto Skiver Knives/ Tread Cutters, among others. The firm is led by Mr. Lokendra Sheth and Mr. Chaitanya Sheth, partners. The manufacturing facility is located at Latur (Maharashtra).

### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.

### Limitation regarding information availability

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower). Acuite endeavoured to gather information about the entity/industry from the public domain. Any rating with the suffix 'Issuer not cooperating' is assigned without any management interaction with the issuer entity or any data / information from the entity. Sometimes this non co-operation by a rated entity may be due to a result of deterioration in the credit risk profile of the entity.
