Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) and reaffirmed the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 19.00 crore bank facilities of OHM SRINIVASA PAPER BOARDS PRIVATE LIMITED (OSPBPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Ohm Srinivasa Paper Boards Private Limited (OSPBPL) was incorporated in 2011. Promoted by Mr. Srinivas, Mrs. Latha Srinivas, Mr. M. Krishnan and others, OSPBPL is a Tamil Nadu-based company that manufactures craft papers, duplex boards and other paper products by converting waste paper into pulp. The company, led by Mr. Shrinivas, Managing Director, utilises around 37.50 percent of its total production capacity of 120 tonnes per day. It procures raw material (waste paper) from local suppliers and caters to customers in Tamil Nadu.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for

conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
