Acuite has reviewed the long term rating of '**ACUITE BB-**' (read as **ACUITE double B minus**) and short term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs. 13.88 crore bank facilities of Raj Fabrics (RF). This rating is now an indicative rating and is based on best available information.

Raj Fabrics (RF) was established in the year of 1992 by Mr. N. Ponnuraj. The firm is engaged in manufacturing of Grey Sheetings and Yarn Dyed Fabrics. The manufacturing is located in Tiruppur, district of Tamil Nadu. The firm has installed capacity of 1.75 lakh meters per month and actual production of 1.50 lakh meters per month.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
