Acuité has downgraded the long term rating to '**ACUITE B+**' (read as **ACUITE B plus**) from '**ACUITE BB-**' (read as **ACUITE double B minus**) and downgraded the short-term rating to '**ACUITE A4**' (read as **ACUITE A four**) from '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs. 13.88 crore bank facilities of Raj Fabrics. The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

Raj Fabrics (RF) was established in the year 1992 by Mr. N. Ponnuraj. The firm is engaged in manufacturing of Grey Sheetings and Yarn Dyed Fabrics. The manufacturing is located in Tiruppur, district of Tamil Nadu. The firm has installed capacity of 1.75 lakh meters per month and actual production of 1.50 lakh meters per month.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
