Rating Rationale

*The issuer did not co-operate; based on best available information.

Acuité has reviewed long term rating of '**ACUITE B**' (**read as ACUITE B**) and short term rating of '**ACUITE A4**' (**read as ACUITE A four**) on the Rs. 14.25 crore bank facilities of Yash Metal Impex Private Limited. This rating is now an indicative rating and is based on the best available information.

Non-cooperation by the issuer/borrower: Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Yash Metal Impex Private Limited incorporated in 2010 to take over the running business of Yash Metal (established in 2001) and Nico Metal (established in 2007). The company is promoted by Mr. Yashpal Pichholiya and Mrs. Vandana Pichholiya. The company is engaged in trading of non-ferrous metal like tin ingots, zinc ingots, lead ingots and nickel cathodes, etc. The company has 4 Godowns located in Bhiwandi with storage capacity of 300-400 tons in aggregate.
