**The issuer did not co-operate; based on best available information.

Acuité has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 8.50 crore bank facilities of R S Travel and Tours India Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

New Delhi-based company, R S Travel & Tours India Private Limited (RSTPL) was incorporated in 2007 by Mr. Krishan Kumar Jain and Mrs. Nisha Jain. The company is an authorized IATA (International Air Transport Association) agent, books travel tickets apart from offering holiday packages and providing visa processing services.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
