Acuité has downgraded the long term rating to '**ACUITE BB-**' (**read as ACUITE double B minus**) from '**ACUITE BB**' (**read as ACUITE double B**) and reviewed the short-term rating of '**ACUITE A4+**' (**read as ACUITE A four plus**) on the Rs. 20.05 crore bank facilities of Concept Cars Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

The Uttar Pradesh-based Concept Cars Limited (CCL), established in 2010, is an authorised dealer of Maruti Suzuki India Limited. The company led by Mr. Yash Agarwala and Mr. Surya Agarwal has a showroom and service centre at Hardoi (Uttar Pradesh). CCL also undertakes sale of second hand cars through True Value Channel.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
