Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B**' (read as ACUITE B) and short term rating of '**ACUITE A4**' (read as ACUITE A four) on the Rs. 10.00 crore bank facilities of JDC India Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

West Bengal based - Incorporated in 1995, JDC India Limited (JIL) is engaged in the milling of parboiled rice and has an installed capacity of 50 tons per day. Promoted by Mr. Basu and family, the company is led by Mr. Alope Basu, Mr. Ajay Basu and Mr. Ashim Basu. The company also provides cold storage facility for potato traders and exports electrical goods to Doha. The cold storage facility has an installed capacity of 1,40,000 quintals (for potato).

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
