Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus) from 'ACUITE B' (read as ACUITE B) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 10.00 crore bank facilities of JDC India Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

West Bengal based - Incorporated in 1995, JDC India Limited (JIL) is engaged in the milling of parboiled rice and has an installed capacity of 50 tons per day. Promoted by Mr. Basu and family, the company is led by Mr. Aloke Kumar Basu, Mr. Ajay Kumar Basu, Ms. Suprovat Chattopadhyay, Mr. Anil Eknath Khadye and Mr. Asim Kumar Bose. The company also provides cold storage facility for potato traders and exports electrical goods to Doha. The cold storage facility has an installed capacity of 1,40,000 quintals (for potato).

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
