Rating Rationale

SMERA has reviewed the long term rating of '**SMERA B**' (read as **SMERA B**) on the Rs. 6.60 crore bank facilities of Balaji Rice Mill (BRM). This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower: SMERA has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and SMERA's policies.

About the Rated Entity:

BRM was established in 1975, by Mr. Ramalinga Reddiar (Proprietor). The firm is engaged in the processing and trading of rice at Villupuram, TamilNadu and has a processing capacity of around 9,000 kg of rice per day.

In FY2015-16 (Provisional), the firm reported profit after tax (PAT) of Rs.0.10 crore on operating income of Rs.36.27 crore against PAT of Rs.0.08 crore on operating income of Rs.30.41 crore in the previous year.
