Acuite has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 6.60 crore bank facilities of Balaji Rice Mill (BRM). This rating is now an indicative rating and is based on the best available information.

BRM, established in 1975 by Mr. Ramalinga Reddiar, is a proprietorship firm engaged in processing and trading of rice and bran, based in Tindivanam at Villupuram. BRM runs a rice mill in Tindivanam (Villupuram) with a capacity of processing around 9000 Kg per day.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
