Rating Rationale

Acuité has downgraded the long-term rating to '**ACUITE C**' (read as **ACUITE C**) from '**ACUITE BB**' (read as **ACUITE double B**) on the Rs.900.00 crore bank facilities of RPW Projects Private Limited (RPW). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk and significant liquidity pressure faced by the Essel Group.

RPW Projects Private Limited (RPW), part of the Essel group was incorporated in 1994. The company was promoted by Essel Infra projects Limited (EIL), the flagship company of the Essel Group. RPW, an EPC contractor company, undertakes projects for the Essel group. It is led by Directors, Mr. Prakash Salikram Shukla, Mr. Pranay Kumar and Mr. Akshay Kirtikar.

Non-cooperation by the issuer/borrower: Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
