**The issuer did not co-operate; based on best available information.

Acuite has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs.8.00 crore bank facilities of Madhusudan Prints Private Limited (MPPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Madhusudan Prints Private Limited (MPPL) incorporated in 1994 is a Gujarat based company engaged in manufacturing and trading of knitting fabrics promoted by Mr. Bharatbhushan Nandwani & Mr. Manoharlal Nandwani. The company purchases yarn from the local suppliers and manufactures knitted fabrics. The company has recently started embroidery works.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
