Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE Single B**) on the Rs.8.00 Crore bank facilities of Madhusudan Prints Private Limited (MPPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Madhusudan Prints Private Limited (MPPL) incorporated in 1994 is a Gujarat based company engaged in manufacturing and trading of knitting fabrics promoted by Mr. Bharatbhushan Nandwani & Mr. Manoharlal Nandwani. The company purchases yarn from the local suppliers and manufactures knitted fabrics. The company has recently started embroidery works.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
