Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) on the Rs. 8.00 Crore bank facilities of Madhusudan Prints Private Limited (MPPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Madhusudan Prints Private Limited (MPPL) incorporated in 1994 is a Gujarat based company engaged in manufacturing and trading of knitting fabrics promoted by Mr. Bharatbhushan Nandwani & Mr. Manoharlal Nandwani. The company purchases yarn from the local suppliers and manufactures knitted fabrics. The company has recently started embroidery works.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
