Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) on the Rs.12.00 Crore bank facilities of SLN Agro Industries (SAI) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Established in 2009, SLN Agro Industries (SLN Agro) is a Raichur (Karnataka) based partnership firm promoted by Mr. C Nagesh and Mrs. C Geetha. The firm is engaged in the processing of non-basmati rice with an installed capacity of 8 tons per hour.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
