Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) on the Rs. 5.30 Crore bank facilities of Fino Foods Private Limited (FFPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Incorporated in 2015, Fino Foods Private Limited is promoted by the Indore-based (Madhya Pradesh) Muchhal family Mr. Rajiv Muchhal, Mr. Kunal Deep Muchhal, Mr. Dhruv Kumar Muchhal and Bhavya Muchhal and is engaged in the manufacturing and processing of dry pasta under the brand name 'Finosta'. The manufacturing facility located at Indore (Madhya Pradesh) has installed capacity of around 250 tons per month. FFPL commenced operations in November 2016.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
