Acuite has reviewed the long term rating of '**ACUITE BB**' (read as **ACUITE double B**) and short term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs. 13.00 crore bank facilities of Sitaram Energy and Logistics Limited. This rating is now an indicative rating and is based on best available information.

Sitaram Energy, based in Kolkata (West Bengal), was set up in 1978 as a partnership concern by two brothers Mr. Kamal Kishore Mall and Mr. Sitaram Mall. It was reconstituted as a company with its current name in 2007. Sitaram Energy's day-to-day operations are being looked after by Mr. Manish Mall, son of Mr. Kamal Kishore Mall. Sitaram Energy, based in Kolkata (West Bengal), was set up in 1978 as a partnership concern by two brothers Mr. Kamal Kishore Mall and Mr. Sitaram Mall.
