### Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+ (read as ACUITE B plus)**' on the Rs.9.70 crore bank facilities of Shivshakti Cotex (SC). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

### About the Company

Shivshakti Cotex (SC), established in 2013, was promoted by Mr. Jayeshkumar Patel, Mr. Dilipkumar Patel, among others. The firm is engaged in the ginning and pressing of cotton bales, and it also sells cotton seeds. The manufacturing facility is located at Kadi, District Mehsana. SC has 30 ginning machines and 1 pressing machine with a capacity to produce 6000 bales of cotton.

### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

### Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower).
