Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) on the Rs.9.70 crore bank facilities of Shivshakti Cotex (SC) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Shivshakti Cotex (SC), established in 2013, was promoted by Mr. Jayeshkumar Patel, Mr. Dilipkumar Patel, among others. The firm is engaged in the ginning and pressing of cotton bales, and it also sells cotton seeds. The manufacturing facility is located at Kadi, District Mehsana. SC has 30 ginning machines and 1 pressing machine with a capacity to produce 6000 bales of cotton. The registered office of the company is in Gujarat.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
