Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 10.00 crore bank facilities of Shanti Mills (SM) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Shanti Mills (SM) was established as a proprietorship concern in the year 2014 by Mr. Yeedala Hariprasad. The firm is located in Raichur, Karnataka, i.e. one of the major rice-producing states. It is engaged in milling of paddy with main product paddy, rice, broken rice and with by-products like rice bran, husk etc. The firm's manufacturing unit is located in Raichur and has an installed capacity of 8 tonnes of paddy per hour. The firm procures paddy from local farmers in Raichur, Karnataka and supplies to dealers in states like Karnataka, Maharashtra, Tamil Nadu, Gujarat and Kerala.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
