Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) on the Rs. 10.00 crore bank facilities of Shanti Mills (SM) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Shanti Mills (SM) was established as a proprietorship concern in the year 2014 by Mr. Yeedala Hariprasad. The firm is located in Raichur, Karnataka, i.e. one of the major rice-producing states. It is engaged in milling of padding with main product paddy, rice, broken rice and with by-products like rice bran, husk etc. The firm's manufacturing unit is located in Raichur and has an installed capacity of 8 tonnes of paddy per hour. The firm procures paddy from local farmers in Raichur, Karnataka and supplies to dealers in states like Karnataka, Maharashtra, Tamil Nadu, Gujarat and Kerala.

Non-cooperation by the issuer/borrower:
