Rating Rationale

Acuite has reaffirmed the long term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.24.00 crore bank facilities of JAPTECH INDUSTRIES. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Japtech Industries (JI) was founded by the Agarwal family as a partnership firm in 1988. Mr. Naresh Agarwal, Ms. Sunita Agarwal, Mr. Aman Agarwal and Ms. Poonam Mittal are current partners of the firm. The firm is a Tier- I manufacturer of automobile parts, i.e. metal sheet press components. The firm caters to Original Equipment Manufacturer (OEM) like Tata Motors, Mahindra, Piaggio, among others. The firm has two manufacturing units, at Jamshedpur and Pune.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in

the absence of information provided by the issuer/borrower). Acuité has endeavoured to gather information about the entity/industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
