**The issuer did not co-operate; based on best available information.

Acuite has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 6.00 crore bank facilities of Padgilwar Agro Industries. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Maharashtra based - Padgilwar Agro Industries (PAI), a partnership concern established in 1960 is engaged in the manufacturing of sprayers (hand operated, power sprayers, crop cutters) for the agricultural sector. The firm is led by Partners, Mr Chandrashekhkar B. Padgilwar and Mr Tushar C. Padgilwar.

For FY2015-16, PAI reported net profit of Rs.0.58 crore on operating income of Rs.15.16 crore, as compared with profit after tax of Rs.0.67 crore on operating income of Rs.27.00 crore in FY2014-15.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
