## **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B+' (read as ACUITE B plus)from 'ACUITE BB-' (read as ACUITE double B minus)and the short term rating to 'ACUITE A4' (read as ACUITE A four) from 'ACUITE A4+' (read as ACUITE A four plus) on the Rs.35 Cr bank facilities of GRM Foods Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

## About the Company

The Haryana based, GRM Foods Private Limited was established in 1974 as a partnership firm. Later in 2015, the constitution was changed to private limited and is managed by Mr. Pradeep Kumar, and Mr. Neeraj Bala. The company is engaged in the business of milling and processing of basmati rice with an installed capacity of 10 tonnes per hour.

## Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
