Acuité has reviewed the long term rating of '**ACUITE BB**' (read as **ACUITE double B**) and short term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs.14.50 crore bank facilities of Shamsons Polymers Private Limited (SPPL). This rating is now an indicative rating and is based on best available information.

Shamsons Polymers Private Limited (SPPL), incorporated in 1993, is led by Mr. Deepak Batra and Mr. Varun Batra. The company is engaged in the manufacture of footwear such as sports, casual shoes, chappals and sandals at Sahibabad and Noida in Uttar Pradesh and also at Narela in Delhi. The company has manufacturing capacity of 300,000 pairs per shift per month.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
