Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE D**’ (read as **ACUITE D**) on the Rs. 25.00 Cr bank facilities of Jai Hanuman Rice and Gen Mill (JHRGM). The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Jai Hanuman Rice and Gen Mill (JHRGM) is a Karnal-based partnership firm, established in 2008 by Mr. Surinder Kumar and Mr. Hari Krishan. The firm is engaged in processing and milling of basmati and nonbasmati rice.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
