Rating Rationale

Acuité has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE BB-**' (read as **ACUITE double B minus**) and reviewed the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.408.33 crore bank facilities of Ligare Aviation Limited (LAL). This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower:

Acuité has downgraded its rating on the bank facility of Ligare Aviation Limited (LAL). The downgrade of ratings is on account of absence of adequate information to enable Acuité to assess LAL's ability to service its debt.

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

About the Rated Entity:

Ligare Aviation Limited (LAL) incorporated in 1996 provides non-scheduled charter services. The erstwhile Religare Aviation Limited was changed to LAL in 2012. The company is a step-down subsidiary of RHC Holdings Private Limited (RHC) and a 100% subsidiary of Ligare Voyages Limited (LAL). LAL has a fleet of 11 aircrafts which includes three jets, two helicopters and six turboprops. Four turbo props are owned by the company (on its own books) and the rest are on operating lease of 10 years.
