## **Rating Rationale**

Acuité has reaffirmed the long-term rating of 'ACUITE C' (read as ACUITE C) on the Rs. 12.14 crore bank facilities of SMPC INDUSTRIES INDIA PRIVATE LIMITED. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

### **About the Company**

SMPC Industries India Private Limited, incorporated in 2004, is a Chennai-based private company promoted by Mr. Azam Khan. The company is engaged in the processing of steel which includes cutting, shearing and re-shearing of galvanised corrugated sheets on a job work basis. The company procures galvanised steel from Select Galva India Private Limited.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
