Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE C**' (read as **ACUITE C**) on the Rs. 12.14 crore bank facilities of SMPC INDUSTRIES INDIA PRIVATE LIMITED. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

SMPC Industries India Private Limited, incorporated in 2004, is a Chennai-based private company promoted by Mr. Azam Khan. The company is engaged in the processing of steel which includes cutting, shearing and re-shearing of galvanised corrugated sheets on a job work basis. The company procures galvanised steel from Select Galva India Private Limited.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
