Acuité has downgraded the long term rating to '**ACUITE B+**' (**read as ACUITE B plus**) from '**ACUITE BB-**' (**read as ACUITE double B minus**) and the short-term rating to '**ACUITE A4**' (**read as ACUITE A four**) from '**ACUITE A4+**' (**read as ACUITE A four plus**) on the Rs. 19.50 crore bank facilities of Modern Rice & General Mills. The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

Modern Rice & General Mills (MRGM), established in 1981, is a partnership firm based out at Karnal, (Haryana). Initially, the firm had two partners, namely Mr. Vinod Malik and Mr. Davinder Malik. Later, in 2014-15, Mr. Davinder Malik retired and Mr. Devraj Malik joined in as a new partner. The firm is engaged in milling and processing of basmati rice.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
