Acuité has reviewed the long term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs.25.00 crore bank facilities of Gudimetla Sundara Rami Reddy and Company (GSRR). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Gudimetla Sundara Rami Reddy and Company (GSRR), established in 1985, is an Andhra Pradesh based partnership firm promoted by Mr. Gudimetla Rama Krishna and Mr. Gudimetla Sundara Rami Reddy. The firm is engaged in the processing of non-basmati boiled, parboiled and raw rice at West Godavari District in Andhra Pradesh and has installed capacity of 270 metric tonnes per day (MTPD).

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
