Rating Rationale

Acuite has reaffirmed the long term rating of '**ACUITE D' (read as ACUITE D)** on the Rs.25.00 crore bank facilities of Gudimetla Sundara Rami Reddy and Company (GSRR). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Gudimetla Sundara Rami Reddy and Company (GSRR), established in 1985, is an Andhra Pradesh based partnership firm promoted by Mr. Gudimetla Rama Krishna and Mr. Gudimetla Sundara Rami Reddy. The firm is engaged in the processing of non-basmati boiled, parboiled and raw rice at West Godavari District in Andhra Pradesh and has installed capacity of 270 metric tonnes per day (MTPD).

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower). Acuite endeavored to gather information about the entity / industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
