Acuité has reviewed the long-term rating of '**ACUITE BB**' (**read as ACUITE double B**) on the Rs.13.71 crore bank facilities of DAFTARI AGRO PRIVATE LIMITED. This rating is now an indicative rating and is based on best available information.

Daftari Agro Private Limited (DAPL) was incorporated in 1994. The company is engaged in the cultivation, breeding, processing, grading and preservation of certified seeds (oil seeds, soya bean, pulses, paddy among others) which are sold under the 'Daftari' brand name across the country. The Daftari family has been in the business since 1976.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
