Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B+' (read as ACUITE B plus) from 'ACUITE BB-' (read as ACUITE double B minus) on the Rs. 13.71 crore bank facilities of Daftari Agro Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Wardha based Daftari Agro Private Limited was incorporated in 1994. The company is engaged in the cultivation, breeding, processing, grading, and preservation of certified seeds (oil seeds, soya bean, pulses, paddy among others) which are sold under the 'Daftari' brand name across the country. Mr. Shailendra Fulchandji Daftari, Mr. Ravindra Fulchand Daftari, Jainendra Fulchandji Daftari are directors of the entity.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
