This rating is now an indicative rating and is based on best available information.

Sumeet Facilities Private Limited (SFPL) was incorporated in 1992 by Mr. Prabhakar Salunke, Mr. Sumeet Salunke, Ms. Sunanda Salunke, Mr. Ravindra Poman, Mr. Suryakant Pawar and Mr. Nitin Salunke. The company is engaged in providing Integrated Facility Management Services that include housekeeping services such as mechanised housekeeping, gardening, landscaping, solid waste management, pest control, placement and white color staffing, covering more than 200 clients. SFPL is rendering services across Maharashtra, Gujarat, New Delhi, Chhattisgarh and Tamil Nadu.
