#### Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE D) on the Rs. 1962.10 crore bank facilities and Rs. 200.00 crore of Non-Convertible Debentures and the short-term rating of 'ACUITE D' (read as ACUITE D) on the Rs. 250.00 crore bank facilities of Sintex BAPL Limited (SBAPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

#### **About the Company**

Sintex-BAPL, incorporated in December 2007, is a Gujarat-based company engaged in the manufacture of automotive components for Original Equipment Manufacturers (OEMs), tier I auto ancillaries and electrical goods manufacturers in the domestic market. Subsequent to incorporation, Sintex-BAPL acquired automotive business of Bright Brothers Limited, which has been engaged in the automotive business since 1975. As on March 31, 2016, Sintex-BAPL had an aggregate installed capacity of 24,000 metric tons per annum (MTPA) for manufacturing of moulded plastic products. The company is directed by Mr. Amit D. Patel, Mr. Rahul Patel, Mr. Samir Joshipura, Mr. Sandeep M. Singhi, Mr. Pravin K. Laheri and Dr. Gauri S. Trivedi. The company has its manufacturing facilities located at various places like Chennai,

Pithampur, Pune, Sohna, Nasik and Dharuhera.
