Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B Plus**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A Four**) on the Rs.29.50 Crore bank facilities of D K Bharat Simha Reddy (DKSR). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

D K Bharat Simha Reddy was established in 2001 by Mr. D K Bharat Simha Reddy. The firm is engaged in providing road construction service to Telangana Government. D K Bharat Simha Reddy majorly caters to various departments of Telangana Government and during FY19, the firm has started sub-contracting work for National Highways.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
