Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE Bf)rom 'ACUITE B+' (read as ACUITE B plus) on the Rs. 6.97 crore bank facilities of A P A Textiles India Private Limited (ATIPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

A P A Textiles India Private Limited (ATIPL), a partnership firm established in 1981 is engaged in the manufacturing of grey cloth. The company is led by Mr. Ammasaiappagounder Palanisamy, his wife, Ms. Saraswathy Palanisamy and Mr. Dhanasekar Palanisamy. The company procures raw cotton, converts it into cotton yarn and manufactures grey cloth through third parties. Grey cloth is used in the manufacture of home textile items including bed sheets, made ups etc. The spinning unit is located at Coimbatore with installed capacity of 12,000 spindles. The registered office of the company is in Coimbatore.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance

& review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
