Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B)from 'ACUITE B+' (read as ACUITE B plus) on the Rs. 9.80 crore bank facilities of Shree Jee Grain Products Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Karnal based, Shree Jee Grain Products Private Limited was incorporated in 2012. Mr. Robin Garg, Mr. Naresh Kumar Garg, Mrs. Chanchal Garg are directors of the entity. It is engaged in the business of milling and processing of wheat and rice flour and has an installed capacity of 200 tons per day. The company procures raw material from suppliers of Haryana and Food Corporation of India (FCI) and sells its product in northern India.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
