Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B+' (read as ACUITE B plus) and the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 7.50 crore bank facilities of B D Industries India Private Limited (BDIIPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

B D Industries India Private Limited (BDIIPL) is a Madhya Pradesh-based company incorporated in 2009 commenced commercial operations in 2015. The company, promoted by Mr. Dalbair Pal Saini and Ms. Arti Saini, is engaged in the manufacturing of plastic and steel products.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit

rating is based.
