# **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 5.05 Crore bank facilities of Ram Chander and Sons on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

#### **About the Company**

The Lucknow-based, Ram Chander and Sons (RCS) is a partnership firm established in 1991 by Mr. Alok Agrawal and Mrs. Sandhya Agarwal. The firm is the sole distributor for inkjet and dot matrix printers of Epson India Private Limited and also sells processing chemicals, projectors among others of Fuji Films.

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
