Rating Rationale

Acuite has reaffirmed the long-term rating of **‘ACUITE D’ (read as ACUITE D)** on the Rs. 12.50 crore bank facilities of Opal Asia India Private Limited (OA IPL). The rating continues to be flagged as “Issuer Not Co-operating” and is based on the best available information.

About the Company

The Mumbai-based Opal Asia India Private Limited (OA IPL), incorporated in 2007 undertakes repair & maintenance, survey and fabrication of containers. It also deals in trading of flexible bags. The company, led by Mr. Ajith Menon, has operations across 20 locations including Nhavasheva, Mundra, Mangalore, Cochin, to name a few. The promoter has over a decade of experience in shipping and logistics.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
