Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) to the Rs. 5.00 crore bank facilities of JCI CHEMICALS INDIA PRIVATE LIMITED (JCIPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

JCIPL was incorporated in 2000 as a Kolkata-based company engaged in trading of chemicals used in tanning of leather. The company is promoted by Mr. Raghu Nath Sarkar, Mr. Aman Bahri, Mr. Arunava Bhattacharjee.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
