Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 35.00 crore bank facilities of Latala Construction Co (LCC) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Jaipur, Rajasthan based, Latala Construction Co (LCC) was established in the year 1998 as a partnership concern promoted and managed by Mr. Satya Narain Gurjar and Mr. Padam Chand Gurjar. LCC is engaged in execution of civil construction contract works with major focus on construction of roads in Pan India majorly in Rajasthan and Madhya Pradesh.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
