Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B (read as ACUITE B) from 'ACUITE B+ (read as ACUITE B plus) and reaffirmed the short-term rating to 'ACUITE A4' (read as ACUITE A four) on the Rs. 9.80 crore bank facilities of Inmac Computers Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Inmac Computers Private Limited (ICPL), a Mumbai-based company was incorporated in 1992 by Mr. Girish Babu and Mrs. Asha Girish Babu. The company provides IT solutions to banks and financial institutions. ICPL also undertakes tender based projects from Jharkhand and Telangana governments to set up Wi-Fi connectivity in remote locations.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
