**Rating Rationale**

Acuite has reaffirmed the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 20.00 crore bank facilities of Shayona Corporation (SC). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

**About the Company**

Shayona Corporation, established by Mr. Ramesh Dabhi and Mr. Jignesh Patel, a partnership firm, was established in 2005. The firm undertakes construction of buildings, bridges and roads for government and related entities at Nagpur and Thane, Maharashtra. SC is registered as a Class I-A contractor with the Public Works Department, Maharashtra.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
