#### **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus) from 'ACUITE B' (read as ACUITE B) and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 3.50 crore bank facilities of Ganesh Marine Services on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

## **About the Company**

The Pune-based Ganesh Marine Services (GMS), a proprietorship firm established in 2001 by Mr. Digambar Gowande is engaged in the trading of industrial machines and equipments including vibrators, dust collectors, compaction equipments among others. These are used in the automobile and construction industries. The firm has operations in several states including Madhya Pradesh, Maharashtra, Karnataka and Tamil Nadu. GMS imports equipments from China and exports the same to Bhutan and SouthAfrica.

### **Unsupported Rating**

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
