### Rating Rationale

Acuité has withdrawn the long-term rating of '**ACUITE B** (read as **ACUITE B plus**) on the Rs.20.00 crore bank facilities of Shreem Automobiles Private Limited (SAPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

The rating is being withdrawn on account of request received from the company and NOC received from the banker.

### About the company

Shreem Automobiles Private Limited (SAPL) was incorporated in October 2016 by Mr. Pranav Rajendra Ghule and Mr. Tanuj Rajkumar Pugalia is an authorised dealer for Hyundai Motors India Ltd (HML). The company has a showroom admeasuring 2037 sq. ft. at Kandivali West, Mumbai.

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date. This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Acuité has considered the standalone financial and business risk profiles of the firm to arrive at the rating.
