Acuité has reviewed the long-term rating of '**ACUITE BB**' (**read as ACUITE double B**) and short term rating of '**ACUITE A4+**' (**read as ACUITE A four plus**) on the Rs.14.75 crore bank facilities of Hemant Surgical Industries Limited (HSIL). This rating is now an indicative rating and is based on best available information.

Hemant Surgical Industries Limited (HSIL), a proprietorship firm established by Mr. Hanskumar Shamji Shah in 1983 was reconstituted as a public limited company in 1989. The Mumbai-based company distributes medical equipments, disposables and also manufactures injectable formulations.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
